### Sailing Instructions (SIs)

#### 1 RULES

**1.1** This event is governed by the rules as defined in *The Racing Rules of Sailing*.

#### 2 OTHER DOCUMENTS THAT GOVERN THIS EVENT

2.1 LCYC Courses and Race Marks on LCYC website (http://lcyc.info/racing/documents).

#### 3 CHANGES TO SAILING INSTRUCTIONS

- **3.1** Any change to the sailing instructions will be posted before 0900 the day it will take effect, except that any change to the schedule of races will be posted by 2000 on the day before it will take effect.
- **3.2** Changes to a sailing instruction or to the designated course may be given on the water following the raising of the "L" flag with one sound.

#### 4 COMMUNICATIONS WITH COMPETITORS

- **4.1** Notices to competitors will be posted on the official notice board located online at (http://lcyc.info/racing/documents).
- **4.2** On the water, the race committee intends to communicate with competitors via radio on VHF 72.

#### 5 SIGNALS MADE ASHORE

**5.1** Signals made ashore will be made from RC boat located on the main dock.

#### 6 SCHEDULE OF RACES

- **6.1** Race date as per the LCYC website: Racing Events / Lake Champlain Yacht Club.
- **6.2** There will not be a skippers' meeting ashore. On race day prior to first start boats shall check in with race committee noting they are registered and intend to compete in the race.
- **6.3** Race committee will use VHF 72 to communicate with the fleet, first broadcast at 0900, others may follow.
- **6.4** The orange start-line flag will be displayed once the committee boat is on station and the line is set.
- **6.5** The first warning will be at 1030.

**8.1** The racing area includes Lake Champlain.


#### 9 COURSES & MARKS – NUMBERED COURSES

- **9.1** The course will be either a numbered course or a Windward/Leeward course.
- **9.2** Numbered courses will be from LCYC Courses & Race Marks on LCYC website (<a href="http://lcyc.info/racing/documents">http://lcyc.info/racing/documents</a>).
- 9.3 Course numbers will be displayed on the race committee boat and may be announced on VHF 72.
- **9.4** Separate courses may be displayed and announced for JaM and Spinnaker divisions. If so, the Spinnaker course will be denoted by 'S' and the JaM course by 'J'.

## 10 COURSES & MARKS – WINDWARD-LEEWARD COURSES 10.1 COURSE DIAGRAMS

Courses are identified as follows:

Windward-Leeward: WL.



#### 10.2 COURSE BOARD

Race courses will be signaled from the Race Committee boat as follows:

**CLASSES**: The first line on the board indicates the class. J for Jib & Main classes and S for Spinnaker classes:

- **10.3** The windward mark will be signaled using a board on the stern of the signal boat. If the windward mark is a drop mark, a "D" and the magnetic heading to that mark will be displayed.
- **10.4** All marks of the course shall be left to port.

#### 11 THE START

- 11.1 Races will be started using RRS 26 with the following change: There will be a one-minute gap between the Spinnaker division start signal and the JaM division warning signal:
  - Spinnaker division warning 1030 start 1035
  - Jib & Main division warning 1036 start 1041
- 11.2 The starting line is between a staff displaying an orange flag on the signal boat at the starboard end and the course side of the port-end starting mark.
- 11.3 Following a long postponement the orange starting line flag will be displayed with 4-5 short blasts at least four (4) minutes before the AP is lowered.
- 11.4 Boats whose warning signal has not been made shall avoid the starting area during the starting sequence for other boats. The starting area consists of a rectangle defined by the starting line plus its extension 150 feet beyond each end and 150 feet on the non-course side of the start line.
- 11.5 If any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified the race committee will attempt to hail her sail number. Failure to hail her number, failure of her to hear such a hail, or the order in which boats are hailed will not be grounds for a request for redress. This changes RRS 62.1(a).
- **11.6** A boat that does not start within ten minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2.

#### 12 SHORTEN COURSE

**12.1** When either the Spin flag or JaM flag is displayed with the S flag the shortened course applies only to that division.

#### 13 CHANGE OF THE NEXT LEG OF THE COURSE

- **13.1** When either the Spin flag or JaM flag is displayed with the C flag the course change applies only to that division.
- 13.2 The race committee will announce the new course orally, or by VHF 72, or both.

#### 14 THE FINISH

- **14.1** The finishing line is between a staff displaying an orange flag on a race committee boat and the adjacent mark.
- **14.2** If the race committee signals a shortened course, the finishing line shall be between an orange flag on a race committee boat and the adjacent mark. This changes rule 32.2.
- **14.3** If the race committee is absent when a boat finishes, she shall report at her first reasonable opportunity her finishing time in local universal time, in hours/min/sec, when the course side of the finishing mark is abeam of the boat's mast, leaving the mark on the proper side. Should the race committee not be available directly, reporting should be made via email to scorer@lcyc.info.
- **14.4** A boat that retires from the race shall notify the race committee at the first reasonable opportunity.

#### 15 TIME LIMIT

**15.1** The time limit for the first boat to finish is 1600.

#### 16 PENALTY SYSTEM

**16.1** Appendix V, Alternative Penalties, V1 & V2 apply.

#### 17 PROTESTS

- **17.1** RRS Appendix T Arbitration applies to this event.
- **17.2** All forms required for filing a protest may be found on the LCYC website <a href="http://lcyc.info/racing/documents">http://lcyc.info/racing/documents</a>.
- 17.3 The formal protest shall be submitted on standard forms to the Regatta Chairman within twenty-four (24) hours of a boat's finish.
- 17.4 Forms may be submitted via email to regatta@lcyc.info.

#### 18 SCORING

**18.1** Boats will be scored on corrected time using the time-on-time method based on their Lake Champlain PHRF rating.

#### 19 SAFETY REGULATIONS

- 19.1 A boat that retires from the race shall notify the race committee at the first reasonable opportunity.
- **19.2** Any time while racing and wind speeds exceed 20 knots all crew members are required to wear a personal flotation device while on deck.
- 19.3 Any time while racing and conditions merit all crew members are strongly advised to wear a personal flotation device while on deck. Conditions to be considered include but are not limited to crew position, MOB risk, the wearing of foul weather gear, water temperature, air temperature, sea state, wind speed and physical ability.
- 19.4 No race will be started when sustained winds are in excess of 25 knots.

#### 20 RISK STATEMENT

20.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

#### 21 INSURANCE

**21.1** Each participating boat shall be insured with a valid third-party liability insurance with a minimum cover of \$300,000 per incident or the equivalent.
