- 4.5. An error in the Quickbooks setup, prior to my tenure, resulted in an underpayment of our federal unemployment tax from 2018-2021. We were set up as a 501(c)(3), which doesn't pay unemployment tax, we are actually a 501(c)(7), which does. This has been corrected for 2022. We have also paid the back taxes for 2018-2021 in the amount of \$1289.93. We may owe additional interest and penalties. I have peremptorily appealed any penalty.
