5. Proposal to By-Laws amendments

- a. Article 2: Members.
 - i. Section 1 (b), Family member definition to include domestic partnerships as recognized by the BOG.
 - ii. Section 1 (h), Inactive membership definition to allow Members for valid reasons, as determined by the BOG, to move to Inactive Member status without moving permanently "outside the club service area".
 - Section 6, Initiation fee An Approved Applicant must pay the mooring waitlist fee within 30 days to remain an Approved Applicant.
 - iv. Section 8, Meetings only one Annual Meeting must be held, in the Fall.
- b. Article 3: Board of Governors.
 - i. Section 2, Nomination and Election of Members of the Board of Governors, Commodore and Treasurer - BOG transition and "Change of Watch" - to happen in January regardless of whether a formal "Change of Watch" ceremony is held in January. Requires the BOG to hold an annual "Change of Watch" ceremony.
 - ii. Section 4, Committees eliminates language requiring standing committee chairs to be members of the BOG. This change should have been included in the previous bylaws change lowering the minimum BOG size.
- c. Article 4: Officers and Other Positions.
 - i. Section 2 & 3, Appointment of Officers & Election of Auditors tracks the amendment in Article 3 by providing that new BOG members, Auditor, Treasurer and Commodore terms to begin at the January BOG meeting, not Change of Watch. Makes this language consistent with the Article III BOG transition changes.
 - Section 4, (g) Auditors audit must be completed by a fixed date (May
 1) rather than 10 days prior to Spring workday.
- d. Article 5: Use of Club Facilities
 - Section 3 Request for Mooring Rights Approved Applicants, who within 2 seasons of original offer, do not accept an offered mooring, will no longer be an Approved Applicant.
- e. Definition of Family Units are to be changed to align with more official, commonly used language will be formalized by the BOG before 12/31/2022.
- f. Motion to approve changes to By-Laws, 1st: Chris Leopold, 2nd: Bob Desorbo, Motion approved.
- g. Changing any applicable language in Log to be gender neutral
- h. Motion to approve changes to By-Laws, 1st: Chris Leopold, 2nd: Bob Schumacher, Motion approved.
