2. <u>Compost Presentation</u>

- 2.1. Gunnar Sievert
 - 2.1.1. Proactively research composting since it will be law in the near future (Households July 2020).
 - 2.1.2. Gunnar, Ann and Jeff Bordeaux are on the composting sub committee
 - 2.1.3. Have investigated compostable plates, utensils, napkins, cups...etc. Only a slight increase in cost.
 - 2.1.4. Looking to start in June 2019
 - 2.1.5. Will need to educate the members and put up signage on how to compost
 - 2.1.6. Discussion did occur about managing our own compost on site. It could bring animals without an appropriate facility and the amount produced by the club would not be enough to create usable compost.

 - 3.4.1. Al Lewis and Joss Besse have been acquiring the permits to extend the ramp into the water, by dropping concrete slabs. Estimated cost is \$14,500. Would like to do this work in the Fall 2019. Anticipated to be a 2-3 day job.
